EXPLANATORY NOTE

This Registration Statement on Form S-8 is being filed by GoHealth, Inc. (the “Company”) with the Securities and Exchange Commission (the “Commission”) for the purpose of registering an additional 1,347,861 shares of the Company’s Class A Common Stock, par value \$0.0001 per share (“Common Stock”), issuable under the following employee benefit plans: (i) the Company’s Amended and Restated 2020 Incentive Award Plan, which, as a result of the operation of an automatic annual increase provision therein, added 1,123,218 shares of Common Stock, and (ii) the Company’s 2020 Employee Stock Purchase Plan, which, as a result of the operation of an automatic annual increase provision therein, added 96,508 shares of Common Stock.

Pursuant to Instruction E of Form S-8, the contents of the Registration Statements on Form S-8 filed with the Commission on [July 15, 2020](#) (File No. 333-239879), [February 10, 2021](#) (File No. 333-252962), [March 23, 2022](#) (File No. 333-263787), [June 6, 2022](#) (File No. 333-265442), and [January 13, 2023](#) (File No. 333-269223) are incorporated by reference herein; except for Items 3 and 8 which are being updated by this Registration Statement.
