## EXPLANATORY NOTE

This Registration Statement on Form S-8 is being filed by GoHealth, Inc. (the “Company”) with the Securities and Exchange Commission (the “Commission”) for the purpose of registering an additional 225,000 shares of the Company’s Class A Common Stock, par value \$0.0001 per share (“Common Stock”), issuable under the Company’s Second Amended and Restated 2020 Incentive Award Plan.
